Thomas Berry, Esq.

Tom Berry has provided legal services to Maine residents for over 40 years. He is a graduate of the University of Maine Law School, worked in the criminal division of the Maine Attorney General's office and served as first assistant district attorney in Sagadahoc, Lincoln, Knox and Waldo Counties before entering private practice. He served as Lincoln County's Judge of Probate from 1988-2016. He maintains a general practice at Berry & Burbank in Boothbay Harbor.

Jay Bradshaw

Jay Bradshaw served as the Director of Emergency Medical Services for the State of Maine from 1996 - 2015. During his tenure with Maine EMS, he served as a member of the Maine Elder Death Analysis Review Team and was instrumental in the development and implementation of the EMS Community Paramedicine Pilot Project. Jay has been involved in emergency medical services for more than 30 years as a volunteer first responder, a field paramedic, a municipal ambulance director, and then with Maine EMS from 1987-2015. Jay is a past president of the New England Council for EMS and served on the executive board for the National Association of State EMS Directors for several years. He has been a site reviewer with the Commission on Accreditation of Ambulance Services since 1993 and participated in international EMS outreach in Canada, Ireland, and Israel. In retirement, he has continued to work with the National Association of State EMS Officials on projects relating to ambulance safety and information technology.

Vice Chair of Academic Affairs, Department of Family Medicine, Keck School of Medicine, University of Southern California

She provides cognitive assessment and short-term mental health treatment in a collaborative geriatric primary care setting. As the Vice Chair of Academic Affairs in the Department of Family Medicine at the Keck School of Medicine at USC, Dr. Olsen is involved in a number of research and program grants that focus on interprofessional geriatric education and elder abuse education and prevention. She is particularly interested in elder mistreatment as it occurs in the context of dementia caregiving and understanding decisional capacity. To reduce potential injuries in the home, the CP has the ability to evaluate the resident's living space and conduct a home safety check, identifying any hazards, as well as addressing any recommendations made that may make daily tasks easy to achieve.
